- i.) But figure out a sustainable way to manufacture stickers, instead of just asking Rachael to manually make hundreds of them.
 - g.) Could be a morale booster within group.
 - h.) Patreon could also be a way to dispense physical goodies.
 - i.) At level X, you get a sticker; level Y, a pin; level Z, a shirt, etc.
- i.) Nina will take point on pricing out the manufacture of these items, possibly in conjunction with Chris, Rachael, and others with expertise.
