Norwalk Gamer Symphony Orchestra Minutes for the Board Meeting of Wednesday, March 1st, 2023

Lexi moves to accept the minutes as read. Stephen seconds.

Officer Reports

- 1.) Budget Report, by Stephen
 - a.) \$1,799 across various accounts.
- 2.) Fundraising Committee Report, by Nina
- a.) Pre-orders for our t-shirt march initiative has gone very well. 17 people have pre-ordered.
- b.) We've been trying to get more Patreon subscribers from within our own membership. Jared is working on additional content there to entice people to sign up.
 - c.) Ray Breitones is researching grants.
- 3.) Stage/Music Committee Report, by Ben
- a.) Ben has a meeting next Tuesday, the 7th of March, with the director of the Norwalk Conservatory of the Arts to network with him, and inquire about using their performance space as a rehearsal venue. This should hopefully be larger space to accommodate our larger group.

Old Business

- 1.) Summer Concerts Ben introduces motion, Lexi seconds.
- a.) Ben had a meeting with Chris Carney from the Simsbury Library today, and we locked in September 24th as our performance date. 93% (all but two of survey respondents) were able to make this date.
- b.) Ben negotiated payment; we can make at least \$300, but could possibly argue for more.
 - c.) Chris will send us room dimensions and multimedia capabilities soon.
- d.) Ben will work with Nina and the social media committee to get some basic backdrops we might be able to project on a screen behind us during the performance. Ben moves to close the floor, Lexi seconds.

New Business

- 1.) Allocate \$90 to buying checks Stephen introduces motion, Lexi seconds.
 - a.) Only Bryan dissents, motion passes.
- 2.) Discuss merchandise budget numbers Nina introduces motion, Lexi seconds.
 - a.) We need to allocate \$700 to produce our currently planned merchandise.
 - b.) If we sell it at prices we've discussed, we would have made \$1,109 in "profits."
- c.) We're aiming to spend around \$90 on stickers. We might be changing the price on the stickers, which would adjust our expected "profits." *Nina moves to close the floor, Lexi seconds.*
- 3.) Motion to allocate \$700 to Fundraising Committee for merch orders *Nina introduces motion, Lexi seconds.*
 - a.) Unanimous assent, motion passes.

- 4.) Motion to discuss RetroWorld Expo Ben introduces motion, Lexi seconds.
- a.) Ben chatted with Kris Krohn, the director of RetroWorld Expo, a couple days ago. He wants us to play again.
- b.) Ben requested a better time slot, and Kris said he can't give us a better time slot in that panel room, but could give us a different time slot in the lobby outside the rooms.
 - c.) Pros of landing position:
- i.) Being out in the open, our sound might transmit to the lower floor, so people might hear us, and we would be able to attract people up to see us.
 - ii.) We can have a more flexible start time.
 - d.) Date is Saturday, August 26th.
